We have the pleasure to invite you to attend the **hybrid** Ecodesign and Energy Labelling Consultation Forum meeting on Vacuum Cleaners, Air Heating and Cooling Products and Games Consoles. It will take place in Room 2A, Centre A. Borschette, rue Froissart 36, 1040 Brussels, on **11 December 2023** from 10:00 to 17:00, Brussels time.

This EELCF meeting will be both a physical and a virtual meeting, the virtual meeting taking place via a WebEx video conference. You are not required to have a WebEx account to join the meeting.

For physical participation to the meeting:

Provided that the capacity of the meeting room allows for it, we hope to be able to accommodate one expert per Member State in addition to the official representative, and two representatives per association.

For organisational and security reasons of access to the meeting centre, registration to the event shall take place electronically via **email** (ENER-ENERGY-LABELLING@ec.europa.eu) by **4 December 2023** at the latest.

For virtual participation to the meeting:

To ensure a good balance between Member States and associations, the number of representatives per association should not exceed 5 people in total (sum of physical and virtual participants). For organisational reasons, registration is also required for participation in the virtual meeting. Registration to the event shall also take place electronically via email (ENER-ENERGY-LABELLING@ec.europa.eu) by **4 December 2023** at the latest.

After registration to attend the meeting, the link to the virtual meeting will be sent to the registered participants at the latest by **Thursday 7 December**.

- Everyone remains muted (unless speaking when invited by the Chair)
- Only audio connections, no video
- Signal through chat only, if you would like to speak, indicating the organisation that you represent
- Short oral intervention or question, preferably not longer than 2 minutes
